8. Appointments will be made for one year on contract which may be extended depending on the assessment of performance of the incumbent during the contractual period as well as the need of the University.

The University may verify the antecedents or documents submitted by a candidate at any time including at the time of appointment or during the tenure of his/her service and in case it is detected during the time of recruitment process and also at any point of time after the appointment that the documents submitted by the candidate are fake or the candidate has deliberately misled by submission of fake/ forged documents, his candidature/ service will be forthwith cancelled/ terminated without assigning any reason.
10. Incumbents to be appointed on final selection to this post are liable to be deputed amongst different locations of the University.
11. Incomplete application will not be entertained.

13. No TA/DA shall be paid to candidates for attending interview.
