Performance of such Assistant Professor (on contract) will be reviewed every year by IQAC or as decided by the Competent Authority.
- 8. Assistant Professor (on contract) to prepare themselves for submitting reports in supplied Formats for (i) Half-Yearly Self-Appraisal Report and (ii) Yearly Self-Appraisal Report to be submitted to Registrar.
- 9. The fixed monthly remuneration (fixed) be given to the Assistant Professor (on Contract) subject to the recommendation of the expert committee and approval of the competent authority.
- 10. The University may verify the antecedents or documents submitted by a candidate at any time including at the time of appointment or during the tenure of his/her service and in case it is detected during the time of recruitment process and also at any point of time after the appointment that the documents submitted by the candidate are fake or the candidate has deliberately misled by submission of fake/forged documents, his/her candidature/service will be forthwith cancelled/terminated without assigning any reason.
- 11. The prescribed essential qualifications/experience indicated above is bare minimum and mere possession of the same will not entitle the candidates to be called for interview. The university reserves the right to raise the cut-off level of eligibility criteria than those indicated under 'Essential Qualifications' for the respective posts. The University will have the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed for the same.
- 12. Incumbents to be appointed on final selection to this post are liable to be deputed amongst different locations of the University.
