Sub: Uploading of data in β -CWMS/ rectification of data already uploaded in the β -CWMS portal of the University.

Dear Sir/Madam,

You are aware that the Inspection Department had requested you to upload the data in the beta version of the Computerised Web based Management System (β -CWMS) of the University vide letter No. 2751/IC-132/2020 dated 18.09.2020. It may kindly be noted that the Examination Department of the University is presently utilising the data uploaded by you in β -CWMS (particularly Faculty Information System) in terms of involvement of the faculty members of the affiliated colleges in the examination system of the University. The Inspection Department of the University is sharing those data with the Examination Department of the University. At the time of sharing of those data of Faculty Information System (FIS), it is found that the particulars of individual faculty members like phone number and email id have not been furnished **correctly** (i.e. repetition of email id and phone numbers). Obviously, the Examination Department of the University is not in a position to involve those faculty members in the Examination System of the University unless those information of faculty members (phone number and email id) **are not being furnished correctly**. As a result of that the Examination Department of the University is unable to create the login credential of the respective faculty member for submission of Continuous Assessment (CA) of the students. **In this context, it is made clear that the University has decided not to consider those faculty members of the affiliated colleges particularly in connection with the submission of CA and other Examination related activities whose particulars have not been uploaded in beta version of Computerised Web based Management System (β -CWMS) of the Inspection Department of the University.**

In view of the above, I am directed to request you to upload the data in the β -CWMS/ rectify the data already uploaded in the β -CWMS in consultation with Shri Pritimoy Sanyal, Convener, β -CWMS within **7th January, 2021 positively**.

Kind cooperation in this respect from all concerned will highly be appreciated.
