In terms of Advt. No. AICTE/Regulation Bureau-AP/2026-27 dated 26.11.2025 of the Member Secretary of AICTE, this is hereby notified for the information of all concerned that

- (a) A Society, registered under the Societies Registered Act, 1860 through the Chairman/Secretary of Society or
- (b) A Trust, Registered under the Indian Trust Act, 1882 as amended from time to time or any other relevant Acts through the Chairman/Secretary of the Trust or
- (c) A Company established under Section 8 of the companies Act, 2013 or
- (d) Central / State Government / UT administration or by a Society/ Trust registered with them.
- (e) The above bodies shall apply individually or under Public Private Partnership (PPP)/Build-Operate-Transfer (BOT) mode through an Officer authorized by Central/State Government/UT.
- (f) A company having any foreign equity directly or indirectly as shareholding shall not be permitted to apply for setting up a Technical Institution (with exceptions provided by the Government).

desiring to **establish NEW COLLEGE** to conduct **AICTE approved courses** are required to follow the procedural steps as stated below in order to get the affiliation from this University in the academic session, 2026-27.

Furthermore, Organising/Sponsoring body desiring to establish **NEW COLLEGE** to conduct **Council of Architecture (COA) approved courses/Pharmacy Council of India (PCI) approved courses** as the case may be are required to follow the procedural steps as stated below in order to get the affiliation from this University in the academic session, 2026-27.

The Management of the college desiring affiliation from the University is hereby informed that this University will not grant affiliation to an Institution approved by AICTE beyond the date as will be stipulated in the Academic Calendar of the AICTE to be published in the official website of AICTE (@www.aicte-india.org).

In case **Council of Architecture (COA)/Pharmacy Council of India (PCI)**, the University will follow the last date of affiliation as will be stipulated by the Regulatory Authorities.

Application fee @ INR 15,000/- per UG course and @ INR 20,000/- per PG course in the form of Demand Draft drawn in a Nationalised Bank in favour of Maulana Abul Kalam Azad University of Technology, West Bengal, payable at Kolkata are to be deposited at the time of submission of **book binding form** stated in 1 below:

1. The documents (Photocopy) stated hereunder are to be submitted in **book binding form** (Hard copy) as well as softcopy (in Pen Drive)
 - i. (a) Trust Deed/Society Registration related documents including MOA as per Act 1860/Company established under Section 8 of Companies Act 2013.
 - (b) Name of the President and Secretary of the organizing body of the proposed college along with their address mentioning email and Mobile Ph. No
 - (c) Name of the proposed college and its location.
 - ii. Land Deed of the proposed college.
 - iii. Land use certificate from the competent authority as designated by West Bengal Government,
 - iv. Land conversion certificate from the competent authority as designated by the West Bengal Government,
 - v. Mutation Certificate
 - vi. Government Pleader Certificate on marketable title of land and building,
 - vii. Receipt of tax Clearance from competent L & LR Department.
 - viii. Building plan of the institute approved by Competent Authority and fees remittance receipt for sanction of Building Plan.
 - xi. Order of Panchayat/Zilla Parishad/Municipality/ Municipal Corporation/Development Authority/Notified Area Authority for starting construction/building to erect a building.
 - x. Panchayat/Municipality/ Municipal Corporation upto date tax clearance of your proposed college,

- xi. NOC for Fire Safety issued by the competent Authority.
- xii. The test report of water supply in the proposed college campus & source of water supply.
- xiii. Land Continuity Certificate.

The book binding form containing the abovementioned documents and also the documents of NOC as mentioned at Sl. No. 2 below will be checked by the legal experts & proposals which will be prima facie found in order will be processed for the physical inspection/digital inspection of the proposed college campus. **Book Binding containing NOC of the State Govt. as mentioned at Sl. No. 2 will only be processed. Book Binding without NOC of State Govt. will not be processed.** For such legal vetting an amount of **Rs. 15000/-** has to be paid in the form of Bank Demand Draft along with application. If deficiencies are pointed out in the 1st time legal vetting, the compliance has to be submitted in respect of deficiencies pointed out in the 1st legal vetting with an amount of **Rs. 10,000/-** for the purpose of 2nd time legal vetting. For each legal vetting (3rd/4th so on as the case may be) an amount of **Rs. 10,000/-** will be charged and those will be remitted in the form of Bank Demand Draft to the University.

2(a). For the purpose of issuance of **University No Objection Certificate (NOC)**, a **demand draft of Rs. 25,000/- (Rupees Twenty-Five Thousand Only) in favour of Maulana Abul Kalam Azad University of Technology, West Bengal** is required to be deposited as the Processing Fee of issuance of University No Objection Certificate (NOC).

(b). **Submission of No Objection Certificate (NOC) of the State Govt.** prescribed vide Notification No. 885-Edn. (CS)/OM-152L/2012 dated 17.09.2015 of the Higher Education Department, Govt. of West Bengal regarding “West Bengal Policy and Guidelines for the Setting up Self-financing Degree Colleges in West Bengal”.

(c). Furthermore, the Notification of the Higher Education Department under Memo No. 412-Edn (T)/HED-20014(99)/14/2023-TECH dated 14.09.2023 regarding NOC is attached. That will also be followed by the University strictly.

3. The Beta version of Computerized Web Management System (β-CWMS) consisting of Faculty Information System (FIS) and Infrastructure Information System (IIS) are required to be filled up by the Trust/ Society/ companies established under Section 8 of the Companies’ Act 2013 desiring to establish new college. User Account & password along with the User Manual of CWMS will be collected from the Office of the undersigned on production of the MAKAUT, WB Bank challan documents remitting the Inspection Fee. The inspection parameters as stated in the FIS & IIS will be verified by the Inspection team who will be visiting your new college campus after receiving invitation for the inspection from the management of the proposed college. Furthermore, the Self Assessment Report & Inspection Report (SAR & IR) is available in our website (doc & pdf Format). The same may kindly be filled up and the filled up SAR & IR is required to be handed over to the Inspection Team who will visit the college campus physically/digitally.

The last date to fulfill the formalities as required in Sl. Nos. 1 & 2 and Sl. No. 3 above for the academic session, 2026-27 is **06.02.2026** and **11.02.2026** respectively. However it is made clear that subjects to the receipt of the **(a) AICTE approval and (b) approval of Pharmacy Council of India (PCI)/Council of Architecture (COA) as applicable**, affiliation matter will be considered in respect of those proposed colleges having the following: (i) the documents stated in 1 above will be found in order by legal expert, (ii) the satisfactory report of the inspection team of MAKAUT, WB who will visit the proposed college campus physically/digitally subject to remittance of inspection fee prescribed by University and (iii) submission of State Govt. No Objection Certificate (NOC) as mentioned under Sl. No. 2.

All concerned are to note and act accordingly.
