Three formats of self-assessment report and Inspection Report (SAR & IR) in respect of AICTE/PCI/COA and Non-AICTE Colleges are up-loaded in our University website: [www.makautwb.ac.in](http://www.makautwb.ac.in) and [www.insp.makautwb.ac.in](http://www.insp.makautwb.ac.in) in both pdf (non-editable) format and doc (editable) format.

**It is emphasized that the institution should be ready for inspection round the year with filled up self-assessment report and inspection report. Whenever the Inspection team of MAKAUT, WB will visit the institution physically, the duly filled in self-assessment report and inspection report (one hard copy) is to be submitted to the Inspection Team at the very beginning of the inspection of the college and another soft copy of the same is required to be submitted to the Inspection Department 48 hours prior to the holding of Physical Inspection. In case of digital inspection, the soft copy of SAR & IR is required to be submitted to the Inspection Department 48 hours prior to the holding of Digital Inspection. During the inspection, the self-assessment report and inspection report made from the end of the college will be verified by the inspection team.**

In view of the above, it is expected that you should be ready for inspection at any point of time. In this context, you are requested to provide other information in addition to the information given in the self-assessment report and inspection report pertaining to your institution, if called for by the Inspection Team of MAKAUT, WB during the visit. Inspection date may be intimated over telephone but no individual correspondence regarding inspection will be made.
