No: RBAICTE/M-13/2415/2024/2025-26 dated 04.11.2024 of the Member Secretary, AICTE copy enclosed) has invited applications for approval from all technical Institutions for conducting Technical Programmes/Courses including course of Management for the academic session, 2025-26.

It has also been notified in the said Public Notice of AICTE that submission of online application for the session 2025-26 in respect of all approvals shall begin on **06<sup>th</sup> November, 2024** and end on **20<sup>th</sup> November, 2024** for Existing Institutions /Universities running other than BBA / BCA /BMS courses and shall begin on **30<sup>th</sup> December, 2024** and end on **13<sup>th</sup> January, 2025** for Existing Institutions /Universities with standalone BBA / BCA /BMS courses. The last date for submission of online application with penalty (as per provisions of APH 2024-27) for Extension of Approval based on self-disclosure for existing Institutions is permitted up to **2<sup>nd</sup> February, 2025**.
