No: AICTE/Regulation Bureau-AP/2026-27 dated 26.11.2025 of the Member Secretary, AICTE copy enclosed) has invited applications for approval from all technical Institutions for conducting Technical Programmes/Courses including course of Management for the academic session, 2026-27.

It has also been notified in the said Public Notice of AICTE that submission of online application for the session 2026-27 in respect of all approvals shall begin on 28th November, 2025 and end on 20th December, 2025 for (l) Existing Institutions running Programmes in: (A) Engineering & Technology - All levels, (B) Management-only PG level, (MBA/PGDM/PGCM/FPM), (C) Computer Applications - PG level (MCA), (D) Applied Arts & Craft - All levels, (E) Hotel Management and Catering Technology, - All levels, (F) Design - All levels, (G) Planning- All levels, and (2). Existing Institutions applying for BBA / BCA/BMS under NPNL Category. Submission of online application for the session 2026-27 in respect of (1). Existing Institutions running only BBA/BCA/BMS and (2). Existing Institutions running only BBA/BCA/BMS and are applying to other programmes/levels under the NPNL Category and shall begin on 19th December, 2025 and end on 12th January, 2026. The last date for submission of online application with penalty (as per provisions of APH 2024-27) for Extension of Approval based on self-disclosure for existing Institutions is permitted up to 20th January, 2026.

The Management of the college desiring affiliation from the University is hereby informed that this University will not grant affiliation to an Institution approved by AICTE beyond the date as will be stipulated in the Academic Calendar of the AICTE to be published in the official website of AICTE (@www.aicte-india.org).
