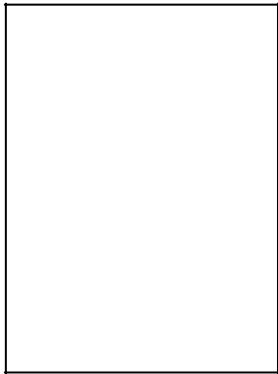

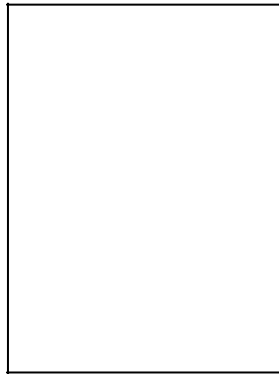

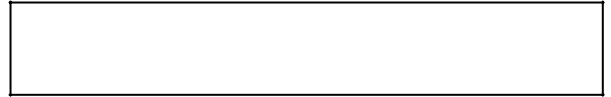

# **GUIDELINES FOR FREE STUDENTSHIP SCHEME FOR UNDER-GRADUATE AND POST-GRADUATE STUDENTS OF MAULANA ABUL KALAM AZAD UNIVERSITY OF TECHNOLOGY, WEST BENGAL (Formerly WEST BENGAL UNIVERSITY OF TECHNOLOGY)**

## **1. Introduction:**

Higher Education has had enormously played a role in the history to build the nation all over the world. It is not possible to rise in standards of living and culture without strengthening the higher education system in the country. To materialize as a powerful nation, there is an urgent need to bring in talented boys and girls in the fold of Under-graduate and Post-Graduate education by way of providing them some sort of good incentives in the form of free studentship etc. The University always stands by with the economically weak background meritorious students for higher learning.

## **2. Objectives of the Scheme:**

The objectives of the scheme are:

- a) to promote and nurture talent;
- b) to reward economically weak meritorious students at the Under-graduate and Post-graduate level;
- c) to build up academic excellence at Under-graduate and Post-graduate level studied in this university.

## **3. Eligibility for students who can apply under Free-studentship (Wavier) Scheme:**

- i. Annual family income of the candidate must not be more than Rs. 2.5 lakh from all sources (supporting documents have to be attached)
- ii. The Free studentship is limited to the Tuition fee only. All other fees will have to be borne by the beneficiary.
- iii. Candidate must be domicile of West Bengal. (Supporting documents have to be attached)
- iv. Merit rank in State Level Joint Entrance Examination (WBJEE)/National Level Entrance Examination (JEE-Mains) for B Tech/B Arch/Pharmacy etc, if any.
- v. For In-House AICTE/Non-AICTE Courses(Under Graduate/Post Graduate), CET Rank/ PGET Rank/ JEMAT Rank /Class XII Result/Under Graduate Result etc., if any
- vi. Candidates selected under Tuition Fee Waiver (TFW) Scheme of West Bengal Government or West Bengal Swami Vivekananda Merit-cum-Means Scholarship Scheme or enjoying any other Scholarship/Waiver Scheme will not be eligible under this Free studentship scheme of this University.
- vii. Candidates, admitted through GATE RANK for pursuing M Tech, enjoying GATE Fellowship will not be eligible under this Free studentship scheme of this University.
- viii. Candidates of MBA Courses admitted through All India Entrance Examination and entitle to get scholarship will not be eligible under this Free studentship scheme of this University.

- ix. For the purpose of determining Annual Family Income Certificate of the parents/guardian of the applicant students (considering all sources of Income of the family members), each student must submit original Income Certificate issued by:
- a) District Magistrate, Additional District Magistrate, Deputy Magistrate, Deputy Collector, Sub-Divisional Officer, Block Development Officer.
  - b) Superintendent of Police, Additional Superintendent of Police, Sub-Divisional Police Officer, Deputy Superintendent of Police.
  - c) Commissioner, Additional Commissioner, Joint Commissioner, Deputy Commissioner, Assistant Commissioner of Police Commissionerate.
  - d) Judicial Magistrate of any rank or position in the concerned district or Metropolitan locality or Hon'ble High Court at Calcutta or Hon'ble Supreme Court of India.
  - e) Corporation Area-Commissioner, Additional Commissioner, Joint Commissioner, Assistant Commissioner.
  - f) Assistant Secretary or above in the Secretariat to the Government of West Bengal (including GTA) or Central Government.
  - g) Deputy Director or above in the Directorate to the Govt. of West Bengal or Central Government
- x. Student will apply for Free studentship at the beginning of Second semester. Admission Fee, 1<sup>st</sup> Semester tuition Fees and other fees will have to be borne by the beneficiary at the time of admission.

#### **Cancellation of Free Studentship:**

- a) Misconduct of the awardees, if any, observed or reported.
- b) Unsatisfactory progress report. (having backlog papers in any semester)
- c) Candidates being found ineligible at a later date will face the penal action and will also be liable to refund the entire amount of free studentship.

#### **Implementation of Methodology for Free Studentship:**

- Eligible candidates will submit application in prescribed Form through the Head of the Department of concerned subjects/courses with requisite self attested documents such as Merit Card (if any), Grade Card, original Income Proof, original Domicile Certificate issued by BDO, SDO, DM, ADM or Group-'A' Gazetted Officers etc.
- The University shall prepare a discipline-wise list of selected candidates after screening and scrutiny of the applications.
- The selected list of candidates will be communicated to the respective departments/schools.
- The University will provide free studentship to maximum 10% of total Under-graduate and Post graduate students of each department .

#### **Removal of Difficulties:**

If, on account of any lacuna or omission in the provisions of the guidelines or any other reason whatsoever, any necessity arises the Hon'ble Vice-Chancellor may pass any order for addition or alteration of the above rules and regulations at any time.
