3	Minutes_42nd EC Meeting	<p>(b) Placed for consideration a report on EKTA Incubation Centre.</p> <p>1) The overall condition of the management of EKTA Incubation Centre-TBI is not found in good shape. We need to make a lot of decisions regarding our existing incubatees as a lot of money is yet to be recovered from them relating to TDB Soft Loan and Service Charges. At the same time we have to evolve mechanisms for attracting new incubatees from the University Stakeholders as well as from the interested and capable persons from our ecosystem.</p> <p>2) There is an urgent need to revive the financial health of the Incubation Centre as there are no avenues of systematic resources mobilization to make the Centre self-reliant. The Incubation Centre is still financially dependent on the University Budget even after so many years of its establishment.</p> <p>3) We also need to make our presence felt at National Level to attract more funds from different statutory bodies so that the incubation centre can add more success stories in its record.</p> <p>4) It is pertinent to mention here that the Governing Body, which is the highest decision making body of EKTA Incubation Centre is formed for tenure of every 3 years.
