**Terms and conditions of Fellowship**

Full Institute Fellowship (for MS Program): Full tuition fee support plus stipend per month. Fellowship is guaranteed for the first semester. Continuation is subject to your satisfactory academic performance and identification of research area.

**Duration:** The fellowship is initially awarded for a period of one semester. It will be continued subject to satisfactory academic performance and identification of a research area. Students of research programmes (MS) must decide on a research area and advisor at the end of the first semester or as advised by their programme coordinator. Once the advisor is chosen, normally the financial support comes from the advisor.

**Duties:** All students receiving Institute Fellowship and other scholarships are required to work for the entire year including the summer. They are expected to work for some minimum hours a week (as detailed below) during academic session and full time (at least 40 hours a week) during the summer. The work is in addition to courses and research. The work may be to assist in teaching, research, setting up a lab, organizing conferences, coordination etc.

a. Holders of full or partial fellowships are temporary Institute employees and are expected to be available full time at the Institute during the semester and vacations.

b. Work hours: Under Full Fellowship, a research student must work for 20 hours per week during the normal semester and full-time during summer vacation. Under Partial Fellowship a student must work for 10 hours per week during the normal semester and full-time during summer vacations.

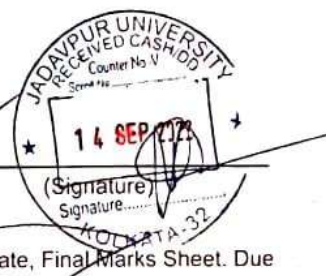

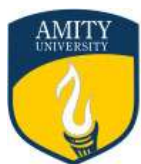



  - c. Production of GATE/NET/DST/INSPIRE/National Exam Certificate
  - d. Production of OBC/EWS/SC/ST/PwD Certificate ( for respective category candidates )
  - e. Production of Relieving Certificate from Employer ( for working professionals )
